South Wheatlands Archive Group:

The group are researching the possibility of a permanent memorial to locals killed in action during the Second World War that have no memorial at present. We only have the name of one brave soldier, and his family have been contacted, seeking permission to display his name (John 'Jack' Morris). Road closures:

Rays Farm Bridge is due to be closed from Tuesday 19th August for 6 weeks for bridge repair work to be carried out. Diversion signs will be set up. Can we please ask everyone to be patient during this time and drive carefully through the village, remembering that there are a lot of small children living in the village. Any problems please contact the Clerk or a Parish Councillor.

Winterburn bridge has been closed since last September due to flood damage caused to the bridge. As you can see from the photograph on the front cover the bridge had to be removed as it was dangerous. It is hopeful, subject to satisfactory ecologist reports, that work will begin around the 26th June to build a temporary bridge until funding is available and work commences next year on a permanent bridge.

Walton Bank, Stottesdon: It is proposed to close this road from 29th September for a 2 week period to allow for carriageway patching and drainage work. The closure will be for day time and week days only.

From the archives:

Letter from the Vicar - July 1939

"Good Hope"
1 Morfa Road
Llandudno

Dear Friends,

I am sure you will all be grieved to hear that the result of my serious accident last April means that I must resign the living of Stottesdon, and must take a complete rest for some time. The doctor says I may be able to do a little light work later on, but such severe internal injuries to a man of my age makes it unwise for me to think of taking on duties of a parish. I have made wonderful progress, but still feel weak.

Mrs. Burnham and I have taken a little house here, on the Great Orme's Road, where we think we may be able to settle happily. We have already found many kind friends here.

I cannot conclude without a few words of acknowledgement to the neighbouring clergy, who have kindly taken celebrations and other Sunday services since my accident and to Wardens and other Church Officers, who have had the struggle to keep up services without a Vicar to help them to pull things together. Mrs. Burnham and I have every hope that the Bishop may be able to get a man for Stottesdon, who will be able to reach that standard of efficiency in your parochial life which we have been striving for, and we will hope to some measure working towards.

We wish you all the best of everything in your individual, as well as your parochial life.

Stottesdon School (extract January 1956)

For many years the Managers have been very concerned about the state of the school buildings, they have not been able to afford the heavy cost of keeping them in order, for their only income is from the rent of the School House. It is obvious to all that the roof needs immediate attention, the classroom used for the Infants is much too small, the cloakrooms are inadequate and the lavatories are disgraceful, to mention but a few things. Naturally the Managers were anxious to do what they could, but to do even a little would cost more than they could afford. Water has been laid on to the School House and a new grate put in one of the rooms because the old one was dangerous to use, these things have been owed to Mr and Mrs Brown for their patient forbearance over many years.

The Vicar talked the whole position over with the Secretary for Education at Shrewsbury and ascertained that to bring the School up to the standard required by the Education Act would cost something between £5,000 and £6,000. The Diocese would have helped a little but even then the Managers would have to raise at least £3,000 and they therefore very rightly refused to burden this small parish, with 585 as population, with a debt of this magnitude. On the other hand they could not allow the buildings to deteriorate any further or the lavatories to remain so offensive any longer so they asked the Ministry of Education to grant the school "Controlled Status". This has been done with the willing consent of the Diocese and the County Education Authority from December 13th 1955.

This means that the County Education Committee are now responsible for all costs of maintenance and repairs, as well as extensions and alterations. But in future those who use the School will have to pay a proper fee, fixed by the County Authority, but when this is compared with paying about £3,000, it is clear that the parish has the best of the bargain. There will only be two Foundation Managers instead of four, but the teaching and worship will not alter; both the head teacher and the assistant are entitled to give Church teaching if willing to do so and the Opening Worship is taken by the head or his deputy. The Vicar can still teach regularly. The School has not been "handed over", but still belongs to the Church; the buildings are ours, but the maintenance of them is now the responsibility of the County Education Authority. The Managers have the right of using them on Saturdays and the two Foundation Managers on a Sunday.

Report of the findings at 'Ned's garden':

The Ned's Garden complex includes two sites, one west of the Southall Bank Brook in Stottesdon and one east of the brook in Billingsley. These two have become known as Ned's Garden West and Ned's Garden East, although Ned's Garden itself appears to have been an early post-medieval smallholding on the west bank. Two trenches were dug in Ned's Garden West and four in Ned's Garden East. Ned's Garden West provided evidence for a medieval working floor and slag dump associated with bloomery iron smelting. Dating evidence provisionally suggests a 12th-13th century age for the onset of smelting. The upper part of the slag dump yields late 16th/early 17th century pottery, but it is not clear whether this indicates continued iron-making activity or simply later disturbance, perhaps associated with the early occupation of Building B.

A building ("Building B") was located in an area previously suspected of having building debris on the surface. The structure included a wall with one side of a doorway together with an internal flagstone floor or hearth. Dating evidence suggests that the structure was short-lived and of 17th century age. The orientation of the wall does not correspond to the existing geophysical evidence for a building, which may suggest that the geophysical survey identified a building associated with the earlier, medieval, use of the site. To the north of Building B, a continuation of the major slag dump yielded pottery provisionally dated as late 17th or more probably 18th century, possibly indicative of interest in slag as a resource for remelting at this period.

On the east bank of the brook the earliest dating evidence was medieval pottery from the margins of a slag dump on the brook side of a ridge above the modern floodplain. This slag deposit is sealed by two layers of redeposited natural pale clay. Similar clay layers were located in two small trenches further east on the valley side, where they were overlain by deposits containing abundant 18th century pottery. On the terrace above the iron smelting remains, interpreted as an ore roasting area in the geophysical survey, a partially burnt clay surface was found immediately below topsoil.

The main trench on the east side of the valley located a substantial leat, with a base 2.35m below the present top of the adjacent ridge and only 0.90m above the summer brook level at the time of excavation (and only 0.5m above the winter brook level at the time of the geophysical survey). The leat contained about 0.65m of water-lain sediments, so would have required a weir to raise water level by about 1.5m to allow water to flow under normal conditions. The exposed side of the leat was also partially covered with a layer of redeposited natural clay. The leat yielded no dating evidence from its water-lain sediments (neither pottery nor usable charcoal), but the later sediments in the leat yielded 18th century pottery. The deposits between and above the various clay layers in the trenches in Ned's Garden East all yielded slag debris, but were clearly not primary slag dumps. It is therefore possible that the clay surfaces are associated with 17th-18th century re-use of the site, perhaps both as a slag quarry and as an area for roasting the ore being quarried in pits higher up on Southall Bank. The leat may be relatively early in this re-use of the site and is likely to have been associated with the waterwheel draining the coal mines situated some 250m downstream, although a stamp for crushing the reworked slag cannot be discounted.

In summary the site shows evidence for medieval iron smelting on both sides of the brook. The west side was utilised for a small building (house?) in the 17th century. In the 18th century a leat was dug through Ned's Garden East to provide power for mine drainage. The leat is accompanied by working surfaces, probably associated with ore roasting for local blast furnaces.
