Parish Council meeting held on Monday 24th March 2025 at 7.30pm in Chorley Village Hall.

#### 0) Public participation:

Parishioner came to complain about the state of the road from Almshouse Bank t Duddlewick and up the SC road to the properties at Duddlewick. Having lived there for 36 years the road is in a shocking state. Any pothole filling does not last, and the main road is also in a dreadful state. Discussions took place regarding this section of road, and it was pointed out that this road is reported monthly to highways, but the Clerk pointed out that all she knew was that a drainage scheme had to be approved along the main road but could not get any further answers. The problem is that we do not have a highways technician to contact.

## 8) Shropshire Cllr's report: report emailed out for March

These had been circulated by Clerk. S Cllrs are now in purdah so not in attendance.

#### 9) Parish matters/problems

- a) Raised by Cllrs road markings outside School 'H' bar Clerk was told that this would not be carried out until they were white lining in the parish but will chase again.
  - Potholes, Sidbury Bank getting worse!

- Bull Ring white lines required on edge of Church Lane as cars are still driving straight out or across! Requested this but had the same response as for the 'H' bar at the school.
- Inappropriate driving when driving passes horse too close, pipping horns etc.
- Hardwickbridge 4 days but photo only show one post, and a large tree stump removed, all other debris left which will still causing flooding. Clerk read out the following reply: The works at Hardwick Forge Bridge were completed on Friday.
  - The Vegetation on the upstream side was removed, as part of the last days work. The road was closed for 4 days for the safety of my team, as we were working on and under the bridge, so although you can only see the new post, there were other structural works taking place underneath.
  - Chairman asked Clerk to forward this email to him and he would respond as the issues raised had not been dealt with.
- Depth marker at Honeysuckle ford can not be seen coming from Hardwickforge. Clerk had reported this previously but will report again.
- b) Bridge in Chorley Woods to Pitt Cottage and beyond Informative report and photographs forwarded to Clerk and Cllrs by Cllr Gutteridge who had been and talked to Mr Edge at Pitt Cottage. As the bridge is getting into a poor state, he needed help in tracing other landowners and responsibilities with this work. He has maintained it for numerous years but feels that he is unable to continue. Report attached.

Clerk was asked to contact SC, Land Registry to try to find out this information.
